The significance of GREA1 has not been fully appreciated by MBC. It should be removed from the focused changes addendum to the draft Melton Local Plan. Its importance to the village of Great Dalby: GREA1 forms an integral part of the designated conservation area - an open swathe of greenfield land flanked on three sides by linear housing. It is the linear characteristic of the village with this backcloth of open land that makes an important contribution to the conservation area's significance. All effort should be made to retain the historic integrity of the area, to retain its sense of time and place. Great Dalby is an excellent example of a linear village with a grade II* listed church and several listed buildings. The village of Great Dalby is set in particularly attractive undulating countryside which includes the site GREA1 proposed for development. When people visit Great Dalby they invariably comment on how attractive and open the village is. Such features are often taken for granted. The local authority has a duty for present and future generations to preserve and enhance the conservation area. Once defiled by inappropriate development, its significance and historic importance cannot be re-instated. Its importance to me: As a resident of Great Dalby for over 30 years I value site GREA1 as a local amenity. It is used by villagers, including myself, to walk the well-trodden footpaths. This is an elevated site and is visible from many key vantage points both within and outside the conservation area, including from the churchyard and from Woodgate Hill. It offers me a sense of peace and tranquility. Although the village has grown and seen development, this has not negatively impacted on its sense of history and its strong agricultural tradition. This development has largely been small-scale infill development on the footprint of redundant

agricultural buildings. Today there are still four working farms in the village and in recent years the site GREA1 has been used as harmonious pasture. Housing development on site GREA1 would not be justified because of the harm that would be caused to the significance of the conservation area, which must be protected.
