"EXCEPT AND RESERVING unto the Vendor and all other persons now or hereafter entitled thereto the right to use the sewers drains pipes and cables now or within twenty one years from the date hereof lying in or over the land hereby conveyed and to enter upon the land for the purpose of making connections therewith and keeping the same in repair all persons using the said sewers drains pipes cables paying a proportionate part of the expense of keeping the same in repair and making good all damage occasioned by the exercise of the right of entry and connection therewith".

3 (14.03.2006) The Transfer dated 27 February 2006 referred to in the Charges Register contains provisions as to light or air and boundary structures.

4 (05.06.2007) The land edged and numbered in green on the title plan has been removed from this title and registered under the title number or numbers shown in green on the said plan.

5 (05.06.2007) The land has the benefit of the rights reserved by but is subject to the rights granted by a Transfer of the land edged and numbered LT399128 in green on the title plan dated 19 March 2007 made between (1) Susan Patricia Hatton and others and (2) Gareth Owain Evans.




