These representations are submitted on behalf of Tony Stimson who has land interests known as 'SOM3' within the adopted Melton Local Plan of October 2018. This site continues to remain suitable, available and deliverable as a 'reserve site' and aligns with the NPPF in that small and medium sites can make an important contribution to meeting the housing requirement of an area.

Policy SS6 states that where monitoring identifies significant and persistent shortfalls in the delivery of housing and employment, infrastructure or spatial distribution that deviates significantly from the plan strategy, or there are changes within the HMA to the objectively assessed need for development of the spatial distribution of growth across the HMA, the Council will consider an early, a full or partial review of the Local Plan to identify alternative or additional development sites. This is supported and SOM3 is a site very capable of being upgraded to a full allocation site from a reserve site.

SOM3 was the subject of an outline planning application for residential development in 2016. As a project team, we respect the decision that the application was premature (it was submitted before the Local Plan was adopted) and in the background are working on various technical documents to provide and evidenced design approach directly addressing landscape, conservation and heritage matters.
