In order to follow the principles as set out to guide the development of the SSN and afford the necessary protection for our local heritage it is my view that the proposed southern relief road should definitely not encroach on either the site or the setting of the St Mary's & St Lazarus's Hospital. It should be routed according to its pre-submission 2016 plan which locates it north of the line G-F-C-B-A (extending from Sandy Lane to Burton Road). I believe any encroachment further south would negatively impact on the Scheduled Ancient Monument by having a detrimental effect on its setting.
